Job Purpose

This position assists District staff and volunteers in the coordination and execution of events, ensuring a positive and safe experience to the public.

Essential Duties and Responsibilities

- Assist in overseeing functions and activities related to events and programs
- Set up for events and programs, register and/or check-in visitors or volunteers, and clean up after events and programs
- Inspect event areas to ensure they are clean and safe for use
- Communicate with the customer/public to ensure satisfaction of their facility event experience
- Document event details for inclusion in various reports and to aid in the development of facility programs
- Provide additional services to facilitate successful events/facility operations including driving tractor and other vehicles, and maintenance
- Perform other duties as required

Education and Experience Required

Additional Information: Must be 18 years of age or older at time of hire.

Hours: May - October; Wednesday – Sunday (hours/days vary and will include weekends and holidays).

Related Experience: Experience in event coordination or planning.
