Job Purpose

This position assists with the maintenance of the District natural areas, ecology and volunteer programs, and native plant nursery in concert with the restoration of forests, prairies, wetlands, and plant communities in order to support and uphold the District's Mission.

Essential Duties and Responsibilities

- Perform maintenance and management of natural communities
- Perform maintenance of the District's natural areas by removal of exotic and invasive species
- Perform annual maintenance, and assist with daily operation of the District's Native Plant Nursery
- Manually and mechanically harvest, clean, sort, and disperse native seed
- Perform handling, mixing, and applying of pesticides using various spray equipment and protective apparel
- Perform pest control program activities for the management of invasive species, which utilize various herbicides (application rates, timing), mechanical control (mowing, hand cutting), biological control, and prescription fire
- Maintain accurate records of related work and pesticide applications
- Perform minor maintenance on mechanical, and/or hand equipment
- Assist Ecology Staff with research, inventory, and data collection. Make recommendations for species control / enhancement programs on District properties
- Lead prescribed fire crew as a Crew Leader in charge of 3 to 6 crewmembers
- Lead field crews in the collection of native plant seed, control of exotic species, installation of plant plugs and/or trees
- Operate equipment such as: tractors equipped with forestry mulcher or rotary cutter; skid steer/rubber tracked loader equipped with bucket, grapple bucket; front end loader/backhoe
- Participate in ecological management programs including sampling of terrestrial and aquatic ecosystems
- Oversee seasonal staff and oversee the work of consultants and contractors
- May participate in deer management program and aerial deer census including overnight responsibilities
- Perform other duties as assigned

Education and Experience Required

Education: BS/BA in Forestry, Resource Management, Biological Science, or related field preferred.

Related Experience: One (1) year of experience in natural resource or an equivalent combination of training and experience.

Describe:	Exposure to elements like, rain, cold, noise, dust, pests, and insects; manual brush clearing and removal; heavy lifting and operating noisy equipment; falling trees; difficult terrain; exposure to smoke and head during prescribed fires and carry 40lb water pump on back; exposure to heat and humidity while applying herbicides and carrying 30lbs on back; chemical exposure, hazardous terrain; deer culling program requires lifting heavy (100+lbs) carcasses

Describe:	Eye protection and steel toe shoes regularly when performing field work. Ear protection around chainsaws and clearing saws. Herbicide application requires the use of all recommended PPE (such as chemical resistant gloves and aprons and Tyvek jump suits.) Chain saw operation requires the use of hard hats, hearing protection, leather gloves, and chain saw resistant chaps. Prescribed fire requires the use of fire resistant Nomex coveralls, fire resistant neck and face shroud, leather gloves, and hard hat. Required PPE for applicable situations.
